## The Bodmer Lab: A Digital World Literature

The Martin Bodmer Foundation houses an exceptional collection of written documents, extending from the very first traces of writing right up to the present day. This collection acquired during the second third of the 20th century differs from other rare book projects on a similar scale through the very scope of its ambition. It was intended to be, in the words of its creator Martin Bodmer, a 'library of world literature' (Bibliothek der Weltliteratur).

The Bodmer Lab is employing digital technology to develop its research into this archive of the human mind. It thus involves close collaborations between specialists in literature, cultural history, book conservation, information technology and computer science.

The Bodmer Lab was created in 2015 by several researchers of the University of Geneva, with the support of the Foundation Ernst and Lucie Schmidheiny, in order to pursue three main objectives: first, by digitizing a significant part of this archive, it will put documents that are usually too rare and delicate to be freely consulted into the hands of researchers, students, and the general public; second, it will demonstrate the Bibliotheca Bodmeriana's strong intellectual coherence and examine in what way Martin Bodmer attempted to realize his ideal of a library of world literature; third, it will experiment new methods of research, both hermeneutical and computational, on such "smart data".
